2. Limited availability, first-come, first-served.
3. Restrictions in Operations of Exhibits. The SouthEast LinuxFest Foundation and its representatives reserve the right to restrict or remove exhibits which, because of noise, method of operation, materials, or for any other reason, become objectionable to the reasonable attendee or the venue. In the event of such restriction or eviction, the SouthEast LinuxFest Foundation is not liable for any refunds, rentals, or other exhibit expenses incurred by the Sponsor.
4. Care of Building. The Sponsor shall not injure or deface the walls or floors of the building, the tables, or the equipment of the conference space. When such damage occurs, the Sponsor is liable to the owner of the property damaged.
5. Catastrophe. In the event that because of war, fire, strike, government regulation, public catastrophe, act of God, or other cause, the conference or any part thereof is prevented from being held, or is canceled by the SouthEast LinuxFest Foundation, the SouthEast LinuxFest Foundation shall determine any refund to a Sponsor after deducting any expenses incurred by SouthEast LinuxFest Foundation but in no case shall the amount of the refund to the Sponsor exceed the amount of the fee paid.
